## Additional Terms and Conditions

I, as the parent/guardian, enter into this Agreement with **The Southwest Center for the Martial Arts**. (Hereinafter referred to as “the School”), and do hereby agree on behalf of myself, my children, and all persons entitled to use the facilities of the School by virtue of this agreement, as follows:

**Waiver and Release:** I and my child or children fully recognize the risks of injury inherent in participation in any fitness or martial arts program. We represent to the School that we have taken all reasonable steps to determine and hereby warrant that we are in good health, and physically capable of participating in the courses of instruction offered by the School. We acknowledge that the School shall make no, and shall have no responsibility to make any independent evaluation of our physical health or fitness. We understand and agree that all participation in any such fitness program or use of the School’s facilities or equipment on or off the premises of the School shall be at our own risk.

We hereby release, indemnify, and hold harmless the School and its officers, directors, employees, instructors, and agents, of **The Southwest Center for the Martial Arts** from and against any claims, demands, cost and liabilities of any kind or nature. These include attorney’s fees and cost, for injury to or death of my children, or myself or of any persons who become entitled to use facilities of the School. In addition, the participation in the School’s off premises activities and agrees that the School shall not be responsible for the conduct of other users of the School’s facilities or equipment or off premises programs.

**Loss/Damage/Theft of Property:** We understand and agree that neither the School, nor its officers, directors, instructors, or employees shall be responsible for any personal property which is damaged, lost or stolen in or around the School or its facilities, or at any of the School’s off premises events.

**Additional Costs:** We understand and agree that there will be special events held at the School, including but not limited to belt test, tournaments, camps, sleepovers, etc., and these events all incur additional fees beyond the amount set forth in this Agreement. We also understand and agree that the cost of uniforms, equipment, supplies are not included in the cost and must be purchased separately.

**Rules and Regulations:** I and my child or children agree to abide by the rules and regulation governing the conduct and operation of the School facilities.

**Photographs:** We hereby authorize the School and its agents to photograph me or my child or children and to utilize such photographs in any print media, including the Internet, for any commercial purpose. We agree that we shall not be entitled to receive any compensation as a result of such use including but not limited to, the promotion of the School.

**Refunds/Cancellation:** There will be no refunds for any reasons. There will be no credit, refunds or make-up time offered for absences and there will be no exceptions to this rule. This agreement is binding and requires 30 days written notice for cancellation.

**Not Daycare:** I understand that the Southwest Center for the Martial Arts is a martial arts school and not a daycare center as such; their stock-in-trade is not supervision and care. Their intent is to teach martial arts, self-defense; physical and philosophical character building skills. I understand that the Southwest Center for the Martial Arts is a drop-in facility and that as such, my child is free to come and go and if my child is to stay at this facility, it is because of my direction and not of Southwest Center for the Martial Arts.

**DISCIPLINE POLICY:** When Southwest Center for the Martial Arts experiences repeated inappropriate behavior for any enrolled child, that child will be given ample verbal warning of their improper action and instruction to correct it. After being set out of the activity at hand, if the student's behavior is not corrected promptly we will call the parent for assistance in changing the child's actions. Upon a second disciplinary action requiring a phone call to the parent, we will **REQUIRE** parents to make arrangements to immediately (in 30 minutes or less) pick-up their child for the rest of the day. Students that are a constant disciplinary problem will be suspended from the program after appropriate warning to the parents.
